PR26560(Health) 2025-26 दिनांक 19.03.2026 के द्वारा प्रकाशित मानवबल की आपूर्ति से संबंधित नई निविदा की Pre Bid Meeting दिनांक 28.03.2026 को आहुत किया गया, जिसमें प्राप्त आपत्ति एवं सुझाव को इस हद तक संशोधित किया जाता है :-

1. EMD की राशि Demand Draft के साथ-साथ Bank Guarantee के रूप में स्वीकार्य होगा।
2. प्रकाशित निविदा की पृष्ठ सं०- (2) क्लॉज - B :- Corrigerdum :- Agencies which have been Blacklisted/ Debarred by Health Dept. Bihar Govt./ Central Govt./ Any State Govt./ Semi Govt. Organization are barred from participating in this Tender. The bids will not considered.
3. प्रकाशित निविदा की पृष्ठ सं०- (3) क्लॉज - 15 Corrigerdum:- Last three F.Y. i.e. 2022-23, 2023-24 and 2024-25 Audit Report from duly qualified chartered accountant report no wing details (Balance Sheet receipt & payment, Profit & Loss, Income and Expenditure Sheet) of their annual turnover should be submitted.
4. प्रकाशित निविदा की पृष्ठ सं०- (6) (Proforma for financial Bid) Corrigerdum :- Manpower (Male/Female) Technical/Non Technical on Job Outsourcing basis.
5. प्रकाशित निविदा के पृष्ठ संख्या-11 के क्लॉज - 08 Corrigerdum :- In case there are more than one bidder at the same position, then to arrive at a decision for award of job having single larger annual work order value (supported by the experience certificate) for providing manpower services (excluding Security & Housekeeping Services) in Government Healthcare Sector will be preferred to break the tie.
6. निविदा प्राप्त करने की अंतिम तिथि प्रथम प्रकाशन से 21 दिन तक होगी। यदि अंतिम तिथि को राजकीय/क्षेत्रीय अवकाश घोषित रहता है तो निविदा अगले दिन संध्या 05:00 बजे तक प्राप्त किया जाएगा।
7. सभी निविदादाता को निदेशित है कि GST विभाग NOC निविदा के साथ अनिवार्य रूप से लगाना सुनिश्चित करें।

**Important Notes :-**

8. Bidder must have an experience of providing similar nature of works for more than 3 years supported by work order/ work agreement. Only experience of state Government/PSU's/4Central Government organization will be taken in to account while evaluation of the tender documents.
  9. Copy of experience certificate in which it is clearly mentioned about number of persons, nature of work, contract value, duration of work must be attached.
  10. Agency/Firm must submit an affidavit that the name, style of firm/company has never changed.
  11. Copy of challan and paid receipt for more than 1000 Nos. of manpower personal enrolled in EPF & ESIC Department in last financial year (FY 2024-2025) should be submitted.
  12. In case there are more than one bidder at the same position, then to arrive at a decision for award of job having single larger annual work order value (supported by the experience certificate) for providing manpower services (excluding Security & Housekeeping Services) in Government Healthcare Sector will be preferred to break the tie. The Agency is solely responsible and liable for compliance to provisions of various Labour, Industrial and any other laws applicable and all statutory obligations, such as, minimum wages, allowances, EPF, Bonus, Gratuity, ESI, etc. relating to personnel deployed at health Department entity. Health Department entity shall have no liability in this regard. The Agency shall comply with all representations, grievances of the associates deployed with health Department entity.
